Poker Run is limited to members of Antelope Valley Harley Owners Group (AV HOG) and invited guests only. Hands are \$5.00 donation each with a limit of two hands per person. High Hand 40% of purse. Low hand 10%. Remaining 50% of proceeds to be donated to charity as decided by the AV HOG Ridgecrest Activity Group (RAG).

High hand winner will be best 5-card hand out of a maximum of 7 cards. Low hand is lowest 5-card hand out of a maximum of 7 cards. Cards 1 through 5 will be drawn at designated stops. One extra card per hand may be purchased at finish for \$1.00 donation. Another card may be had for free by taking Lubkin Road / Horseshoe meadow road loop. (See Maps) Aces are High, Deuces are low. No duplicate cards allowed. Any duplicate cards will be redrawn. Decision of Judges is final. Cutting of a standard deck will break ties, with high card being the winner.

Picnic lunch of Tri tip and sides provided by AV HOG RAG or bring your own fixin's to grill. 3 gas grills will be available. All RAG members are asked to bring a side dish to share. Over night camping spaces also provided free of charge by AV HOG RAG. Picnic lunch will start about 1400.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from any state statute, which would negate or limit the scope of this release and Indemnification Agreement, including but not limited to Section 1542 of the California Civil Code, which provides: "A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which if known to him must have materially affected his settlement with the debtor." By signing this Release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the "RELEASED PARTIES."
